**ADMINISTRATIVE ORDER No. 03. - MW TOLENTINO**

**TO : ALL GRAND LINE OFFICERS, DDGMs, DGLs, GLIs, MASTERS,  
WARDENS AND OFFICERS AND MEMBERS OF THE  
SUBORDINATE LODGES OF THIS JURISDICTION**

**SUBJECT : REPRIMAND TO ALL THE WMs AND WARDENs of LODGES  
UNDER MD R IV MINDORO**

**WHEREAS**, one of the Obligations of a Master Mason is to conform to and abide by all the laws, rules and regulations appertaining to the degree of Master Mason, and to the Lodge of which one may become a member, and to maintain and support the constitution and edicts of the Grand Lodge under which the same may be holden, together with the general regulations of Freemasonry;

**WHEREAS**, one of the duties of the Worshipful Master and Wardens of the Lodge is to guard against the infraction of its By-Laws, the Constitution, By-Laws, Edicts, Ordinances or General Rules and Regulations of the Grand Lodge or the General Regulations of Masosnry;

**WHEREAS**, the holding of a Multi District Convention is sanctioned by the laws, rules and regulations of the Grand Lodge and is a very significant event that during the said convention the Districts thru the Lodges' official delegates elect their nominees for the position of JGW;

**WHEREAS**, in view of the significance of the Multi District Convention, the attendance and participation of the Lodges' official delegates therein is of prime importance;

**WHEREAS**, during the Multi District Convention of Southern Luzon last 07 October 2017, all the official delegates of Lodges under MD R IV Mindoro were not present;

**WHEREAS**, the absence of all the official delegates of Lodges under MD R IV Mindoro is a manifestation of disobedience to the Grand Lodge and incompetence of the Officers of the Lodges;

**NOW, THEREFORE, I, ABRAHAM N. TOLENTINO**, Grand Master of the Most Worshipful Grand Lodge of Free and Accepted Masons of the Philippines, by virtue of the powers in me vested by the Constitution, do hereby render this Administrative Order:

*"By your Grip, we are here to serve, and not be served even beyond the Cabletow."*


